Owner Agreement

This is a contract between McKee's Pet Place (hereinafter called M.P.P.) and the pet owner whose signature appears below (hereinafter called Owner).

Owner agrees to pay the rate for boarding and all services in effect on the date pet is checked into M.P.P. Owner further agrees to pay all costs for special services requested during the pet's stay at M.P.P. All charges will be paid in full at the time the pet is released from M.P.P.

M.P.P. shall exercise reasonable care for the pet while boarding. The liability of M.P.P. shall not exceed the lesser of the current chattel value of a pet of the same species and breed or the sum of \$200.00 per animal boarded. Owner further agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of M.P.P.

Owner specifically represents to M.P.P. that pet has not been exposed to any communicable diseases or parasites. If M.P.P. finds any parasites on pet, it will be treated as required at Owner's expense. Furthermore, if pet is very soiled from boarding, M.P.P. may choose to have pet bathed at Owner's expense before leaving.

It is the Owner's sole responsibility to show proof of current vaccinations required at time of check-in. For the safety and wellness of all pets and persons, no pet will be accepted without proof of current vaccinations.

If pet becomes ill or otherwise requires professional attention, M.P.P. may engage the services of a veterinarian. Owner agrees to pay all charges incurred for this service. M.P.P. is not responsible for charges incurred from a veterinarian after pet is released.

M.P.P. is not responsible for any articles lost or damaged while pet is boarding.

M.P.P. shall be granted a lien on any and all pets for any unpaid charges resulting from services or boarding at M.P.P. Owner hereby agrees that in the event the charges are not paid when due in accordance with this contract, and/or if pet(s) are abandoned, M.P.P. may exercise its lien rights upon fourteen days written notice given by M.P.P. to Owner by certified mail to address provided by Owner. M.P.P. may release any abandoned pet(s) to a shelter or other organization at the sole discretion of M.P.P., and Owner specifically waives all statutory or legal rights to the contrary. If M.P.P. is unable to secure any unpaid charges, Owner shall be held liable for all such costs.
